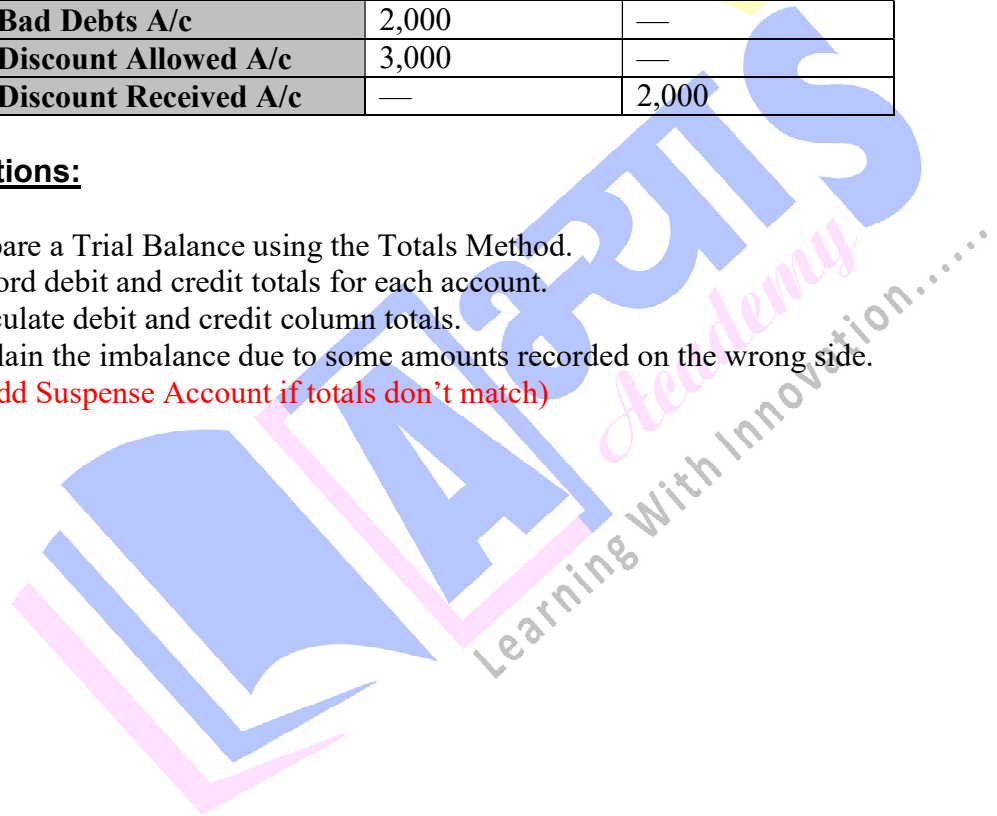
Trial Balance in Accounting using Totals Method

Ques: Below are ledger totals extracted from the books of Sunrise Traders as on March 31, 2025. Some amounts have been recorded on the wrong side.
